Name of Deceased:	Fallon King	

The deceased was a 27 year-old fe/male, 172 cm in height and weighing 160 pounds. A full autopsy with respect to the organs of the deceased was performed (omitted from this report).

The deceased had a blood alcohol level of .08, the level which is deemed unlawful for the operation of an automobile. The level of alcohol does not reveal impairment necessarily nor could it be determined when the deceased last consumed alcohol.

The examination of the body revealed four gunshot wounds. One of the gunshot wounds was located on the deceased's chest with right-side entry. Upon further examination, it appears that the bullet travelled through the heart. Death would have occurred within minutes of this injury.

There were also two gunshot wounds to the right leg, and one to the right hand, which would not have themselves caused death.

Thus, the cause of death was a gunshot wound to the chest.
